TAX DUE DATE

Taxes are due by the close of business on July 2nd, 2025

A 5% penalty will be applied to any current taxes outstanding after the due date.

An additional 5% penalty will be applied after August 5th.

Please note that the penalties also apply to any unclaimed Home Owner Grants.

PAYING YOUR PROPERTY TAXES

There are several other payment methods available, including:

- Online through your financial institution
- By mail (cheque can be post-dated to due date!)
- At the Municipal hall drop box (located to the right of the front door)

REMEMBER to claim your Home Owner Grant (HOG) online, before the property tax due date!



TAX IMPACT ON THE AVERAGE RESIDENCE

The municipal portion of the tax bill amounts to approximately 38% of residential property taxes showing a 4.6% increase in 2025. The remainder of about 62% is collected on behalf of other government agencies and taxing authorities. This portion is showing a 6.7% increase for 2025. The details of the breakdown of the amount paid to each taxing authority is shown on page 2. Overall the total tax bill for the average residential property is about a 6% increase over last year.
