BYLAW NO. 708

A BYLAW

To impose property value taxes for the year 2025 by establishing tax rates.

The Council of the District of Metchosin, in open meeting assembled, enacts as follows:

- 1. This bylaw may be cited as *Tax Rate 2025 Bylaw, No. 708*.
- 2. Property value taxes for the year 2025 are imposed by the establishment of the following tax rates for the year 2025:
 - (a) for all lawful general purposes of the District of Metchosin, the rates appearing in Column A and B of Schedule A to this Bylaw on the assessed value of land and improvements taxable for general purposes;
 - (b) for purposes of the Capital Regional District, the rates appearing in Column C of Schedule A to this Bylaw on the assessed value of land and improvements taxable for regional purposes;
 - (c) for hospital purposes, the rates appearing in Column D of Schedule A to this Bylaw on the assessed value of land and improvements taxable for hospital purposes;
 - (d) for purposes of the West Shore Parks and Recreation, the rates appearing in Column E of Schedule A to this Bylaw on the assessed value of land and improvements taxable for general purposes;
 - (e) for purposes of the Greater Victoria Public Library, the rates appearing in Column F of Schedule A to this Bylaw on the assessed value of land and improvements taxable for general purposes.
 - (f) for the purposes of E-Comm 9-1-1 Dispatch Levy, the rates appearing in Column G of Schedule A to this Bylaw on the assessed value of land and improvements taxable for general purposes.
- 3. (a) After July 2, 2025 the Collector must add to the unpaid balance of current year's taxes on each parcel a penalty of 5% of the amount thereof.
 - (b) The said unpaid taxes, together with the amount added as aforesaid, shall be deemed to be the amount of the current year's taxes due upon such parcel.

- 4. (a) After August 5, 2025 the Collector must add to the unpaid balance of current year's taxes on each parcel, less the penalty added above, an additional penalty of 5% of the amount thereof.
 - (b) The said unpaid taxes, together with the amount added as aforesaid, shall be deemed to be the amount of the current year's taxes due upon such parcel.
