 - Madrona Farm - being involved in Flavor Trails did not help farm financially, but

- helped bring awareness to farming and get non farmers out onto farms
 - Farms with key infrastructure to host large groups can monetize and benefit from initiatives like Flavor Trails.
- Committee aims to inventory farms in Metchosin who have infrastructure in place to host interested groups.

e) Regional Canada Goose Working Group (RCGWC) Report

- Sasha Kubicek, appointed Committee representative, summarised the December 10, 2025 meeting:
 - Presentation from researcher of Fraser Delta geese impact on tidal sedges:
 - Geese are decimating sedge population and eroding estuaries.
 - No plan in place in Fraser Delta to deal with situation.
 - CRD confirmed two culls will occur in 2026 of goose populations, one in Sooke and one in Metchosin.
 - Suggested use of geese meat from culls: Pet food and fertilizer.
 - Geese continue to decimate farmland and continue major operational and financial hardships to farmers.
 - CRD is now focussing budget and mandate to reduce population.
 - Request for farmers to share pictures of before and after geese damage.
