| <b>ELECTOR REGISTRATION</b> |

**If you are not on the list of electors**, you may register at the time of voting by completing the application form available at the voting place and making a declaration that you meet the following requirements:

- 18 years of age or older on general voting day;
- Canadian citizen;
- Resident of BC for at least 6 months immediately preceding the day of registration;
- Resident of the District of Metchosin on the day of registration (at time of voting) OR registered owner of real property in the District of Metchosin for at least 30 days immediately before the day of registration (at time of voting); and
- Not be disqualified under the *Local Government Act* or any other enactment from voting in an election or assent voting and not otherwise disqualified by law.

**Resident electors** must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**Non-resident property electors** must not be a resident elector and must produce **2 pieces of identification** to prove identity (at least one with a signature), **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from the majority of the other property owners. Only persons who are registered owners of the property, either as joint tenants or tenants in common, are permitted to register. Individuals who are holding the property in trust for a corporation or another trust are not eligible.

A person may only register as a non-resident property elector in relation to one parcel of real property in the District of Metchosin.

Those electors who may require assistance as a result of physical challenges are invited to contact the Chief Election Officer as soon as possible in order to facilitate their voting experience.
